



**RULES OF DISTRICT COURT  
THIRTY-SEVENTH JUDICIAL DISTRICT  
COMMONWEALTH OF KENTUCKY**

The Rules of District Court for Thirty-seventh District of Kentucky is amended as follows:

1. Court shall be in session beginning at 9:30 a.m. every Monday in Carter County for the purpose of arraignment, motions in criminal cases, preliminary and suppression hearings, and emergency type motions/hearings. Juvenile cases shall be scheduled on Mondays after 1:30 p.m.. Court will not be in session in Elliott and Morgan Counties on Mondays except for matters in which the Trial Commissioner is authorized to preside over, such matters must be arranged in advance.
2. Court shall be in session beginning at 10:00 a.m. every Tuesday in Morgan County for all types of cases, motions and hearings. Jury trials in Morgan County shall be scheduled as below (see paragraph # 3). Court will not be in session in Elliott and Carter Counties on Tuesdays except as provided above.
3. Jury Trials will be held on Wednesdays in Carter and Morgan Counties as follows: Carter County on the 1st, 3rd and 5th (if any) Wednesdays of each month; Morgan County on the 2nd and 4th Wednesdays of each month. Defendants and witnesses shall appear at 9:30 a.m. the day of trials, the jury shall report by 10:00 a.m.. Court will not be in session in Elliott County on Wednesday except as provided above.
4. Court shall be in session at 9:30 a.m. every Thursday in Carter County for the purpose of civil cases, civil motions and hearings, and probate matters. Court will not be in session in Elliott and Morgan Counties on Thursdays except as provided above.
5. Court shall be in session beginning at 10:00 a.m. every Friday in Elliott County for all types of cases, motions and hearings. Jury Trials shall be held on Friday as scheduled by the Court according to demand(s) for same. Court will not be in session in Carter and Morgan Counties on Fridays except as provided above.
