## ORDER

### **In Re: Increase in Limits on Compensation of Master Commissioners for Calendar Year 2008**

Pursuant to CR 53.08, and in furtherance of the Administrative Procedures of the Court of Justice Part IV, Commissioners of the Circuit Court. Section 7, the Office of Master Commissioner shall be limited in total compensation derived from fees to not more than \$48,000 per annum, unless otherwise approved by written order of the Chief Justice of the Supreme Court of Kentucky.

IT IS HEREBY ORDERED that, upon review and recommendation by the Administrative Office of the Courts and consistent with the compensation information previously distributed, master commissioners in the following counties shall be entitled to personal compensation of \$48,000 for Calendar Year 2008:


