



## AOC to offer changes to CourtNet 2.0 service plans in 2019

Attorneys who subscribe to CourtNet 2.0 will have a new economy option and streamlined service plans in 2019. The Administrative Office of the Courts is pleased to announce these [plan changes](#) for CourtNet 2.0, which provides near real-time, online access to Kentucky civil and criminal cases.

Starting Jan. 1, 2019, CourtNet 2.0 will:

Add a low-cost economy plan for users with minimal needs.

- Increase the monthly rate and case views per month for existing plans to reduce overage charges and simplify billing (compare rates below).
- Change the cost to view/download images from a sliding scale to a flat rate of .35 for all plans.
